LACIGF 12 Report

Title of the session: Closing Ceremony

Session summary:

The closing ceremony was focused on **Iván Zambrana** (Viceministro de Telecomunicaciones, Bolivia), representative of the local authority and María Paz Canales (Derechos Digitales, Chile), representative of the organization committee. The host, also responsible for moderating the closure of the LACIGF, began by thanking everyone present and then inviting them to take a collective photo. Zambrana was asked, as the government representative, to talk about his impressions on LACIGF12 importance. The moderator added that the three-day discussion allowed the construction towards a regional agenda, focused on developing projects to improve the lives of citizens through Internet governance.

Iván Zambrana thanked the community for the engagement in the event, as the dialogue was once again the best way to advance the issues discussed. Zambrana considered that the regional forums are a fundamental tool to develop a technology as powerful and innovative as the Internet, in the search also for a path without discrimination and inclusion. The shared knowledge was highlighted in Zambrana's speech, since he believes that Bolivians learned a lot about possible solutions to their problems, as also happened to visitors. Zambrana spoke about the generosity involved in sharing knowledge and dialogue until identifying challenges, challenges and paths in common, and wished that, for the next forum, there is much progress. The vice minister ended by inviting everyone to LACIGF 13.

The representative of the committee, **María Paz Canales**, thanked the honor and privilege of participating in the organizing committee of the 12th LACIGF, as well as took the opportunity to thank the Latin American community, which remains linked year after year to the Internet Governance Forum of Latin America and the Caribbean, making it grow and strengthen with each edition. She argued for strengthening multisectoralism and work at the local level, always renewing the commitments to the local agenda.

She then presented the statistics obtained during the Forum, indicating that around 313 people attended the 12th LACIGF in La Paz, Bolivia, and 1300 people watched the remote transmission in more than 25 countries, such as Argentina, Chile, Bolivia, Ecuador, Honduras, and Colombia. María also reported, in relation to the face-to-face participants, that 43% of those present were women and that 31% of those enrolled were people under 30.

In one of the greatest efforts also to strengthen participation and firmly establish the forum as a community, in 2019 scholarships were distributed to 18 participants from 9 countries, 65% of them women and 35% minors from 30 years
